ORDER

4. In case any of the Executives is under transfer to any other circle, he may be directed to join as AGM/DE on regular promotion in the circle where he has been ordered for his transfer. Details of such cases be also forwarded to the Corporate Office.

5. The order being issued is subject to the out come of various Court cases pending in several Hon'ble Courts including SLP No. 12595/2009 filed by BSNL in Hon'ble Supreme Court.
