

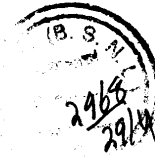

Sub: Refund of CGEIS' 1977 amount to BSNL employees.

The question of refund of CGEIS'1977 amount to those employees of BSNL was under consideration. Now in consultation with Ministry of Finance it has been decided to refund the amount as per the discounted value as indicated in the G.I. M.F. O.M. No. F. 60/14/77-IC dated 21.11.1977.

Accordingly, Concerned BSNL Telecom Circles may be instructed to work out the individual wise amount to be refunded as per the table vide Annexure to the O.M. dated 21.11.1977 referred to above and submit the same to the concerned CCAs along with the service books and simple application form to enable them to carry out necessary check and making payment after making necessary provision of funds in the budget.



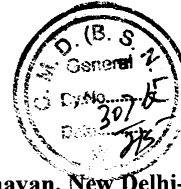
Copy to : All CCAs for taking necessary action. While checking the individual case it may be ensured that they were not the members of CGEGIS'1980 and no refund was made to them from that scheme. It may also be ensured that the amount of subscription recovered from the employees were received in DOT and classified in the relevant Head of Account at least from 1.10.2000 and onwards. After checking the amount of refund for the circle, the estimates may be sent to Budget Branch of DOT(HQ) for making necessary provision of funds under MH 2335 in R.E.2008-09. After necessary check and getting funds from Budget branch the payment may be made to the individual concerned and a certificate to the effect that the amount of refund under CGEIS'77 has been made vide Cheque No dated... .. may be recorded in the service books of the official concerned under the signature of CAO/Sr.CAO. The service books may be returned to the BSNL immediately. The estimates for making provision should be approved by the concerned Head Of CCA units and should be recorded in the request letter if the same is signed other than the Head of CCA units.

Sir,
 In continuation of this department letter No. 5-18(3)/2007-PAT dated 25.10.2006, I am directed to say that the matter regarding refund of saving fund under CGEIS-1977 to the DOT employees who have absorbed in BSNL has been examined in consultation with the Ministry of Finance, Department of Expenditure. The Ministry of Finance, Department of Expenditure while agreeing to refund of the saving fund under CGEIS-1977 scheme to the absorbed employees of BSNL, *vide their U.O. No.7(6)/EV/2007 dated 31 October,2007* has observed that :-

"The matter has been examined. This Department has no objections to payment of reduced benefit under CGEIS-1977 to BSNL employees, in accordance with para 5 of the Scheme. DOT is, however, requested to ensure that these employees are paid only the discounted value as indicated in this Department's O.M. No.F.60/14/77-IC dated 21 November, 1977. The payment of dues to BSNL employees would be subject to verification by DOT."

The Date of issue of P.O. for absorbed BSNL employees shall be taken as the date of cessation of Membership from the CGEGIS-1977 provided that they continued their subscription to the scheme up to that date.

3. Other terms & conditions will remain same. Regarding actual payment of accumulation under 'Saving fund' of the scheme and for other stipulations/conditions, a separate communication will follow from Dy. Director General (A/Cs), Department of Telecommunications.

4. This issues with the concurrence of Telecom. Finance vide their Dy. No 85/ADG(F)/2008 dated 09-04-2008.

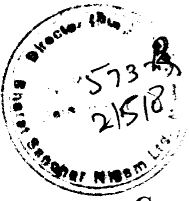
