The local officiating promotion is to be effected after ensuring one day duty as JTO in the new SSA as per Part – A above.

The local officiating promotions are to be effected within a period of 20 days and if any officer does not take up the assignment within 20 days, it will be presumed that they have declined the local officiating promotions and they will be debarred for further officiating promotions for a period of one year.

The posting on transfer as JTO and officiating as SDE should be suitably made by the SSA Heads so that drawal of daily allowance is completely eliminated.

The above arrangements are purely on temporary on local officiating basis for a period not exceeding 179 days to meet the urgent developmental and operational works and provisional. The officers posted in MS A/T will report to the concerned SSAs after completion of A/T Process in Mobile Service.

Pay on promotion will be fixed as per the provisions under FR 22(1)(a)(1). The officers already placed in the upgraded pay scale as per the time bound upgradation policy will not have any benefit in the pay and allowances.

This order is subject to the outcome of WP(C) No. 2616/2006 filed by All India Graduate Engineer Telecom Officers Association (AIGETOA) vs UOI and others before the Hon'ble High Court of Delhi.

It should be ensured that no disciplinary/vigilance cases are pending against the officer and no punishment is current. Vigilance Clearance in r/o the officer may be obtained from the Circle Vigilance Cell.
